Unaudited Quarterly Results For the Three Months Ended 31 March 2012

SUMMARY

The board of directors of Winfoong International Limited (the “Company”) announced the unaudited consolidated results of the Company and its subsidiaries (the “Group”) for the three months ended 31 March 2012 to keep the public informed of the position of the Group.

The Company is an associated company of Hong Fok Corporation Limited (“Hong Fok”) whose shares are listed on the Singapore Exchange Securities Trading Limited (“Singapore Exchange”). As at the date of this announcement, Hong Fok effectively holds 47.75% of the existing issued share capital of the Company. Hong Fok will release its unaudited quarterly results for the three months ended 31 March 2012 on 15 May 2012 pursuant to the listing rules of the Singapore Exchange. The Company hereby releases the unaudited results of the Group for the three months ended 31 March 2012 to keep the public informed of the position of the Group under the general obligation imposed by rule 13.09(1) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“Listing Rules”).

The unaudited consolidated net loss attributable to shareholders of the Company for the three months ended 31 March 2012 was approximately HK\$6,122,000 (2011: HK\$1,939,000).

The unaudited consolidated net asset value of the Company as at 31 March 2012 was approximately HK\$365,532,000 (31 December 2011 audited: HK\$371,654,000).

The Group's results for the six months ending 30 June 2012 will be announced in accordance with the requirements set out in the Listing Rules.
