Unaudited Quarterly Results For the Three Months Ended 30th September, 2004

SUMMARY

The board of directors of Winfoong International Limited (the "Company") announced the unaudited consolidated results of the Company and its subsidiaries (the "Group") for the three months ended 30th September, 2004 to keep the public informed of the position of the Group.

Hong Fok Corporation Limited ("Hong Fok") whose shares are listed on the Singapore Stock Exchange is an associated company of the Company and the Company is an associated company of Hong Fok. As at the date of this announcement, Hong Fok beneficially owns 40.38% of the existing issued share capital of the Company and the Company beneficially owns 20.2% of the existing issued share capital of Hong Fok. Hong Fok will release its unaudited quarterly results for the three months ended 30th September, 2004 on 12th November, 2004 pursuant to the listing rules of the Singapore Stock Exchange. The Company hereby releases the unaudited results of the Group for the three months ended 30th September, 2004 to keep the public informed of the position of the Group under the general obligation imposed by rule 13.09 of the Listing Rules.

The unaudited net loss attributable to shareholders of the Group for the three months ended 30th September, 2004 was approximately HK\$1,011,000 (2003: HK\$5,137,000).

The unaudited consolidated net asset value of the Group as at 30th September, 2004 was approximately HK\$1,218,961,000 (31st December, 2003 audited: HK\$1,224,505,000.)

The Group's results for the year ending 31st December, 2004 will be announced in accordance with the requirements set out in the Listing Rules.
